# The Alpine Convention and the Soil Conservation Protocol

The convention is a framework that sets out the basic principles of all the activities of the Alpine **Convention** and contains general measures for the sustainable development in the Alpine region. It entered into force on March 1995. The core of the implementation of this international treaty are the eight Protocols. In the Protocols, concrete steps to be taken for the protection and sustainable development of the Alps are set out.

Aims of the Soil Conservation Protocol are amongst others to decrease quantitative and qualitative soil impairments, especially by using soil conserving production methods, economic use of land and soil, as well as the control of erosion and the restriction of soil sealing. The Soil Conservation Protocol has therefore the aim to reconcile the different land-use demands with economic and ecological requirements. Given the fact that the Alps are a region with a high ecological diversity, contain vulnerable ecosystems and that the formation and generation of Alpine soils takes place very slowly, the reduction of pollutant inputs in soils need to be reduced and the functionality of Alpine soils need to be permanently maintained. The Alpine Convention's Soils Conservation Protocol therefore seeks to discuss common Alpine solutions for similar soil protection challenges and to elaborate common implementation measures.

# Background and aim of the Alpine Soil Symposium

### Background

The German Presidency of the Alpine Convention supports within the context of the UN year of soils 2015 an assessment of the Soil Conservation Protocol. The project "Assessment of the Soil Conservation Protocol with regard to its implementation and effectiveness in the Alpine region" is financed by the Federal German Environmental Agency within the framework of its Environmental Research Plan.

### Aim of the Soil Symposium

The symposium aims to discuss, elaborate and demonstrate the Alps-wide demands and the implementation status of the Soil Conservation Protocol together with experts from public authorities, researchers, NGOs and private soil stakeholders. Alpine soil protection challenges are going to be discussed in several workshops. The development of joint recommendations for future activities for an enhanced Alpine soil protection and an improved implementation of the Protocol are part of the symposium.
