




Croatian Plans for each of three LCs

Pre-Platform attempts and efforts

Regional BERN COVENTION workshop



- 22 participants representing 9 countries.
- Albania, Bosnia and Herzegovina, Croatia, Greece, “the former Yugoslav Republic of Macedonia”, Slovenia, the Federal Republic of Yugoslavia and Bulgaria.
- „None of the countries is big enough to have its own viable population of any LC species and trans-boundary management of all populations is unavoidable. Also the management and conservation strategies has not been well advanced in all of the states, including that the Bern Convention was not signed in all states too.
- The Major gain: Awareness about the need to prepare LC management plans and about the main approaches in that process.”

 - **General outcome: poor „follow up”, less than 10% of what was agreed ever happened...**
 - **Beware that conflicts are rather low and the potential future threat is due to an inevitable change.**

Dinaric LC platform was desired and attempted since LC Platform was launched in June 2014

- 1. EC Call for tenders (ENV/D.3/SER/2017/0028): Service contract for the establishment of regional/local platforms on coexistence between people and large carnivores
- 2. Interreg Adrion (2018): Transboundary management of Alpine-Dinaric-Pindos population of large carnivores in the Adriatic-Ionian region
- 3. Life DINPIN BEAR (2020): Population level approach for long term conservation of Dinaric-Pindos bear population.

The participants identified the following goals as priorities for the initial discussions of the platform:

- Coordinate and exchange information on management practices, policies and approaches across the region, including national and regional management plans, with the aim of achieving results at population level;
- supporting international networking and exchange of experience between key stakeholders* and authorities;
- capacity building for management tasks related to large carnivores;
- Increased cross-border cooperation in monitoring, e.g. through standardized methods and protocols;
- Establishment of further cross-border projects to support the above-mentioned objectives;
- Raising funds and finding concrete sources of financing to support activities and concrete actions required for the future platform.



For this to be successful, neutral moderation as well as human and financial capacities are required to support the establishment of the platform and the preparation of guidelines for future cooperation.

In order to achieve these goals, the participants invite and encourage the administrative authorities in AL, BG, B&H, HR, N.MK, GR, KS, ME, RS and SL to build on the conclusions of this workshop and to consider the establishment of a regional platform for large carnivores, following the example of the EU Platform, to take these discussions forward.
