Nomination and Management of UNESCO World Heritage Natural Sites in Central Asia

## **Background**

The largely arid ecosystems of Central Asia – steppes, deserts and mountains – host an exceptionally rich variety of native and endemic species, such as the Snow Leopard and the Saiga. However, habitat loss and fragmentation greatly threaten region's biodiversity. Increasing the coverage and connectivity of well-managed protected areas and World Heritage sites would be an effective way to protect it. Yet, there is a limited institutional and technical capacity to use the international instruments for designating new sites or improving the management systems of existing ones. This is particularly true for transboundary sites and shared ecosystems.

## **Project details**

The project has contributed to the conservation of sites with outstanding universal value in Central Asia by identifying priority sites for World Heritage nomination and building capacities to improve the overall management of sites in the region. As a basis, IUCN prepared the 'World Heritage Thematic Study for Central Asia' and announced it at the 43rd World Heritage Committee Session in Baku, Azerbaijan. An in-depth desk analysis followed by a consultative process including two regional workshops and a number of online consultations identified nine sites with potential for World Heritage, either as new nominations or extensions. To improve the capacity for designation and management of World Heritage in the region, a training workshop gathered 25 experts to assess threats and management effectiveness of three existing sites and to identify priorities for their conservation. Additionally, the manual 'Managing Natural World Heritage' was translated into Russian, to help managers in Central Asia understand and incorporate World Heritage concepts and processes into the management of World Heritage sites.
