## 3. Other Measures by the Authorities

There were about 100 cases of repatriation with a total amount of 1500 tons of repatriated waste and 140 cases of environmentally sound waste treatment in local facilities near the inspection place with 1300 tons of waste treated. Some of them may appear later with details, when there is a court decision or an administrative fine. There were also about 200 cases of punishment for minor violations with fines smaller than 200 €. These fines amount to about 23000 €
