Other measures by the authorities

There were about 150 cases of repatriation with a total amount of about 5000 tons of repatriated waste and about 170 cases of environmentally sound waste treatment in local facilities near the inspection place with about 1200 tons of waste treated. These incidents are considered as minor cases as long as there is no significant penalty. As it is a huge amount of data, providing details is regarded as disproportionate. Some of them may appear later with details, when there is a court decision or an administrative fine. There were also about 140 cases of punishment for minor violations with fines not exceeding 200 €. These fines amount to about 16500 €.
