Why are we here ?

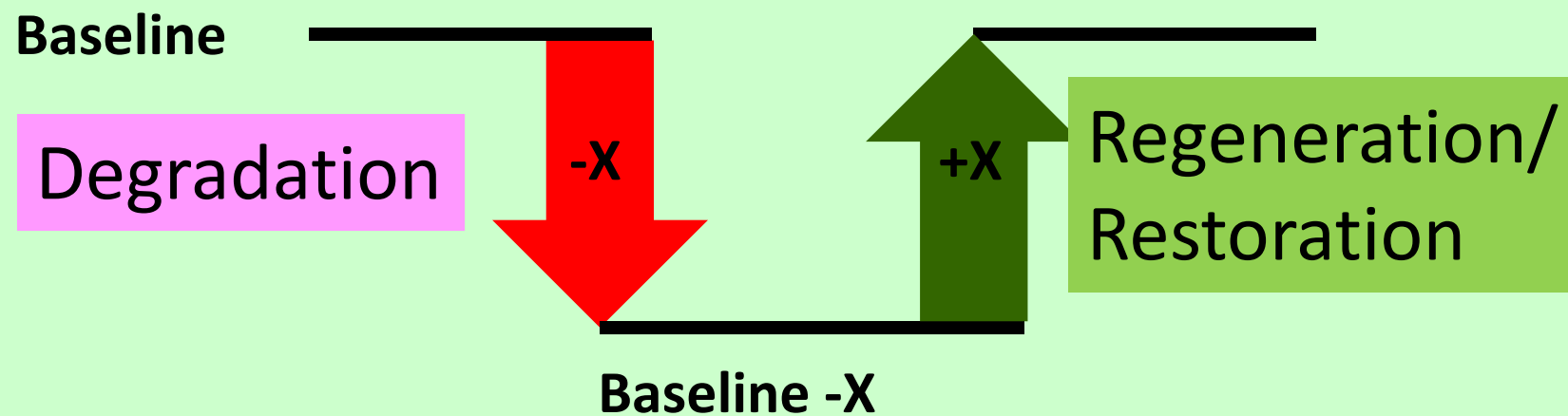
- Land: precondition for well-being of mankind
- Land recognized as a **global concern**
 - Food crisis 2007 – 2008
 - Land acquisition by states and enterprises
- International Year of Soils
- Aim: Sustainable management of land worldwide
- International Governance needed ?

Land Degradation Neutral World



- Outcome Document of Rio+20-Conference, 2012
 - To Strive for a „Land Degradation Neutral World“
- Milestone for sustainable management of land
 - Quantitative Objective
 - Balance between future land degradation and future restoration/rehabilitation must be ZERO

Political Context



- Sustainable Development Goals
 - Proposal of UN Open Working Group, September 2014
 - Negotiations until September 2015
 - Indicators and national implementation
- UNCCD: COP 11, Windhoek Namibia
 - Establishment of Intergovernmental Working Group (IWG)
 - Three Tasks of IWG

UNCCD IWG



- Task 1 Definiton:
 - Intensive discussions
 - Concept no weakened
 - ... the amount of healthy land resources **remains stable or increases**
 - No further specific criteria

UNCCD IWG



- Task 2 Implementation Measures:
 - (1.) Reduce and (2) rehabilitate/restore degradation
 - LDNW either in National Action Plans or single LDNW Implementation Plans
 - List of required types of measures
- Task 3 Measures within UNCCD:
 - List of Questions for four categories
- Germany's Proposal: two more categories
 - Amendments to UNCCD
 - Cooperation with other international bodies

Legal study



- General objective: Proposals for better regulation on International level
 - Input for UNCCD IWG and other international bodies
- Analysis of three national legislations on appropriate legal instruments
 - Focus on different conceptual approaches
 - EU/Germany, US and Brazil
- Recommendations concerning scaling up appropriate instruments as international obligations
