Status quo and visions for the future of gender mainstreaming and its instruments exemplified with environmental and health related research, policy advice and federal administration

Gender mainstreaming and its instruments, including gender impact assessment, can look back upon over 20 years of history. The conference is devoted to encouraging international exchange of experiences with gender mainstreaming implementation in research as well as in the practice of public administration. The conference will consider gender as a value-added and provide a forum for discussing the conditions prerequisite for gender impact assessments. What kind of gendered knowledge is necessary for conducting excellent research on environmental issues and environmental health? What forms of innovative policy advice will help utilize the gender perspective for the benefit of all (female and male) citizens?
