# HOW IS THE TOPIC OF THE PANEL RELATED TO YOUR EVERYDAY PROFESSIONAL LIFE AND/OR YOUR VITA?

My company builds software for the German "Energiewende". The decentralization of the German energy system is part of my daily work.

Personally I try to use the term "just" and "social justice" very carefully. Reaching a state of "justice" is often extremely difficult, both within the German society as well as in international relations. Trying to reach to a "fair sharing" and to "balanced solutions" is much more realistic. WHAT ARE YOU MOST EXCITED ABOUT REGAR-DING THE PANEL AND/OR THE TRANSFORMA-TION CONFERENCE IN GENERAL? In the German constitution the concept of "Sozialstaat" – social justice – has a very strong anchor in the constitution (§2, §14, §20) and gives citizens a strong claim against the state. The ecological transition is also mentioned in the constitution, but much less "armoured" with claims against the state. Actually, when it comes to ecology, the state mostly claims sustainable behaviour from its citizens and its economy. I am curious how specialists from other countries look at that and how the situation is in their countries.

A sustainable transformation of our everyday life and

our economic system can only be reached if all stakeholders and all parts of the society pull together. That means for me politics, business- and industry representatives as well as non-governmental organisations have to find sustainable solutions all together. It is not useful and not goal achieving if every group make their own thoughts without communicate among each other. Discussion, finding commonalties and disagreements is the base of transforming our society. However, in view of climate change and the loss of biodiversity we do not have much time left. It is necessary to act immediately and to find quick solutions to stop these crises. This calls for courageous and exemplary measures which inspire others to do the same. Events like the Sustainability Transformation Conference 2020 can contribute to both.
