



## Invitation

Berlin/Dessau, September 2017

The ongoing activities under the Construction Products Regulation towards harmonising standards defining VOC emissions from construction products for indoor use are an important 1<sup>st</sup> step on the roadmap to Healthy Buildings in Europe.

Like other member states, the German authorities generally welcome the regulatory activities envisaged by the EU Commission in this context. However, the German Ministry of the Environment and the German Environment Agency see an urgent need to discuss the basic concept and the level of ambition outlined in the first draft proposal for a delegated act on the so called "VOC classes".

Most important, the implementation of this concept would cause a significant information gap regarding the potential health risks of construction products for indoor use with the following likely consequences:

- construction experts miss detailed data to select healthy indoor products,
- consumers receive vague risk information not supporting an informed choice,
- national authorities lack information to regulate the (indoor) use of construction products and
- the identification and targeted reduction of possible causes of unhealthy indoor air and possible health damage are hindered.

A policy opinion paper with further explanation will be sent in the next days.
