The Arctic is home to unique habitats that are increasingly threatened by the effects of climate change and the release of pollutants. As the region warms up and becomes more accessible, also the planning and conduct of economic activities put more stress on the region's ecosystems. Due to the inevitable linkages between Arctic and non-Arctic regions, Arctic states and states that do not directly border Arctic regions are responsible to promote environmental protection of the region.

This expert workshop aims to enable exchange and discussion on how Arctic Council observers can engage strategically and practically in Arctic environmental protection. In an exchange with states that are active in the High North, indigenous communities, businesses, research, and civil society, potential solutions are developed for a sustainable development in the Arctic that allows to reconcile a wide spectrum of interests in the region. Topics include in particular climate change and air pollution control, shipping, and tourism.
